- 1.) All paint must be Dunn-Edwards Spartashield/Evershield as specified in the *Foothill Village Paint Specifications* publication, in the color specified and must not be diluted or substituted in any way.
- 2.) All paint used must be flat finish as specified in the *Foothill Village Paint Specifications* publication.
- 3.) Downspouts, vents and electrical service doors must be the same color as the wall they are mounted on.
- 4.) Garage doors are *Coplay Classic* or *Amarr Heritage*, short panel, no windows.
- 5.) The frame of the garage door must be the same color as the garage door. It is NOT considered "trim".
- 6.) Window frames and grids must be brown.
- 7.) The type and color of the front door/security door desired requires Board approval.
